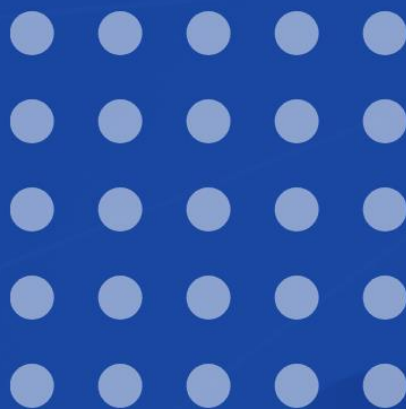

The International Relations Unit (IRU) within the Department of Social Security (DSS) deals with all benefits under all bilateral agreements, international agreements, and covenants which the DSS has entered into, and EU Regulations (EC) Nos. 883/2004 and 987/2009 on the coordination of social security systems. The IRU acts as the point of reference for all who may require support in dealing with the provision of social security benefits which fall under the EU Social Security Coordination Rules or bilateral agreements.
